Mark Cool stated 3 out of the 4 schools have resource officers, the 4th school will have one soon. Sheriffs Department receive a grant to purchase radios for the schools. The Sheriff's Department is having a company come in and map out every school in Osceola County for future use if needed, all officers will have access to the maps in the cruisers. Schools are in need of mental health help with students. County is looking in to contracting a company to help with mental health transports.
